

Regulation of Mahachulalongkornrajavidayalaya University for Affiliated Institutions B.E.2543 (A.D.2000)*

In implemence with article 10 of the Mahachulalongkornrajavidyalaya University Act., B.E. 2540 (A.D. 1997), it is proper to issue the regulation to establisth the affiliated institutions. By the authority of passing of article 19 (2) of the Act of Mahachula-longkornrajavidyalaya University 2540 B.E., the University Council at its Meeting No. 4/2543 B.E. (A.D. 2000) held on May 26, 2543 (A.D. 2000), the following regulations were issued :-

Item 1 This regulation is entitled "Regulation of Mahachula-longkornrajavidyalaya University for Affiliated Institution, B.E. 2543 (A.D. 2000)

Item 2 This is effective from the day following the date of declaration.

Item 3 In this regulation

"Affiliated institution" means any higher institution of Buddhist Education and/ or any other Buddhist Research Institutions which are associated with Mahachulalongkornrajavidyalaya University for the purpose of granting degrees, diplomas or any kind of certificates.

Item 4 To accept the affiliated institutions of Buddhist Education shall be proceeded as follows:

^{*} The following is an English version of the Regulation of Mahaculalongkornrajavidyalaya University for Affiliated Institutions B.E. 2543 (A.D. 2000). In case of doubt, only the (original) Thai version of the text has legal validity.

(1) Whenever there is an institutions requesting for the state of being affiliation with Mahachulalongkornrajavidyalaya University, the Rector of Mahachulalongkornrajavidyalaya University shall appoint a committee to study the data, the feasibility of the administration, the academic proposals and the systems of that institution. Then the committee must report the results of the study and advice to the Rector.

(2) The Rector then shall report to Mahachulalogkorn-rajavidyalaya University's Academic Council that will then report to the Board of Mahachulalongkornrajavidyalaya University Council for approval.

(3) If it is approved, the Board of the University Council shall propose the matter to the Ministry of Education to issue the legal declaration confirming the approval of affiliation between Mahachulalongkornrajavidyalaya University and the external higher institution of Buddhist Education. The Ministry of Education will thereby announce the regal affiliation in the government gazette.

Item 5 The institution to be accepted as the affiliated one must have the following suitable status as follows:

(1) It must be a government institution or an institution of the Buddhist Sangha or a legally recognized academic institution.

(2) Such an institution must have enough budget, staff and management infrastructure.

(3) It has a curriculum and academic system which complies with the aims, policies and research objectives as well as with the Mahachulalongkornrajavidyalaya University.

Item 6 A committee of the affiliated institutions shall be appointed with the following structures:

(1) The chairman shall be Mahachulalongkornrajavidyalaya University Rector or a person appointed by the Rector.

(2) Set committee will include:

The Deputy Rector for Academic Affairs

The Deputy Rector for Planning and Development

The Dean of the Faculties.

(3) Qualified committee members should not be more than 4 persons appointed by the Director.

(4) Representatives of the affiliated institutions should not be more than 4 persons appointed by the Rector.

(5) The Committee and secretaries are the director of the academic affairs.

In case of the external affiliated institution of Buddhist Education, located in a foreign country, the Deputy Rector for Foreign Affairs will be a member of the committee

The committee in the item 6 (3) and 6 (4) shall remain in the position for two years and may be reappointed once again.

In case of the expiration of the early committee's term in the office, a new committee may be appointed and be in power for the period of time remaining to the previous committee.

In case of period of the expiration of the committee's period of sitting, they may remain in the positions until the new committee is appointed.

Item 7 The authority and duties of the Affiliated Institutions Committee are as follows:

(1) To assign, control, and regulate the level of educational standard of the institution.

(2) To consider and assess the curriculum including the academic management and administration of the institution.

(3) To give advice on educational administration, research as well as giving orderly and effective academic service to the affiliated institution.

(4) To give advice on academic policy and co-operation between Mahachulalongkornrajavidyalaya University and the affiliated institutions. (5) To appoint sub-committee to perform any task as authorized by the affiliated Institution Committee.

(6) To follow and assess the activity of the Affiliated Institution and to report their finding to Mahachulalongkorn-rajavidyalaya University at least once a year.

(7) To give advice and guide in the dissolution of the legal relationship of the Affiliated Institution.

(8) To perform other duties as assigned by Mahachula-longkornrajavidyalaya University.

Item 8 The Affiliated Institution shall report their academic performance to the Board of the Mahachulalongkornrajavidyalaya University Council prior to granting degrees, diplomas certificates.

Item 9 The Affiliated Institution shall make a report on the educational and other activities to Mahachulalongkornrajavidyalaya University at least one time per year.

Item 10 The Mahachulalongkornrajavidyalaya University has the authority to dissolve the Affiliated Institution according to the advice of the Affiliated Institution Committee as mentioned in item 7 (7)

Item 11 The Mahachulalongkornrajavidyalaya University Rector shall enforce the compliance of all the above mentioned regulations.
