

Mahachulalongkornrajavidyalaya University Regulation On the Social Services Practice B.E. 2546 (2003)^{*}

In order to manage the social services practice of laity students to proceed in order and efficiency for correspondence with the religious internship students who are monks and novices and to meet the objectives of the University.

Be it, therefore, under the power in accordance with the Article No. 19 (2) of Mahachulalongkornrajavidyalaya University Act B.E. 2540 (1996), the 6/2546 University Council meeting on 30th October, 2546 (2003.) enacted the regulations as follows:

Section I

General Provisions

Item 1: These regulations are called the "Mahachulalongkornrajavidyalaya University Regulation on the Social Services Practice B.E. 2546 (2003)"

Item 2: These regulations are enforced on the day after it is announced.

Item 3: In these regulations,

"**Committee**" means the committee of development and promotion of the social services practice.

"Social Services Practice Student" means the laity students who are studying according to the curriculum of Bachelor of Arts Program of Mahachulalongkornrajavidyalaya University and the one who is practicing the social services.

The following is an English version of the Regulation of Mahaculalongkornrajavidyalaya University on the Social Services Practice B.E. 2546 (2003). In case of doubt, only the (original) Thai version of the text has legal validity.

"Social Services Practice" means practice with social services as the committee has specified.

Item 4: The Rector shall monitor that these regulations are observed.

Section II

Committee of Development and Promotion of Social Services Practice

Item 5: The committees are composed of :-

(1) The president means Rector or Vice-Rector who is appointed by Rector

(2) Ex officio committees are Deans.

(3) Academic representative committee, the member of three monks which are chosen by Academic Council from one who takes a position of Vice-Rector and Director.

(4) Academic representative committee, the kind of teacher of the Faculty, the member of four persons which are chosen by Academic Council from the part of each Faculty.

(5) Qualified committee, the member of three monks or persons which are appointed by the Academic Council according to the advice of the Rector.

(6) Committee and secretary are the Director of Student Affairs.

The Chairman with the agreement of committee chooses a monk committee to be Vice-Chairman

The Chairman may be appointed as a position of Head, Student Religious Internship Section and Student Activities Promotion Section.

Item 6: The committees of Item 5 (3), (4), and (5) have remained in the position for 2 years and may be reappointed once again.

In case of the period of expiration of the committee's term of setting Item 7 (3), (4), and (5),

- (1) death
- (2) resignation
- (3) termination

In case of the period of expiration of the early committee's term in Item 5 (3), (4), and (5), a new committee may be appointed, and be in power for the period of time remaining to the previous committee.

Item 7: The authority and duty of the committee are as follows:

(1) Specification of the policy, characteristic, aims, and efficiency of social services practice, frame and plan of social services practice.

(2) Setting the orientation program, following up, promoting and supporting the social services practice in academic and necessary resource.

(3) Management, administration, and taking the result of social services practice to apply the following policy, plan, and objectives.

(4) Call students and concerned person to explain in front of the committee and suggest the information, punishment to student who violates the regulations.

(5) Setting the sub-committee or person who works for something under the power of duty of the committee.

(6) Other duties are assigned by the University.

Section III

Social Services Practice

Item 8: The aims of the social services practice are as follows :-

- (1) To develop students to have the desired quality.
- (2) To support the University's mission.
- (3) To support the policy of government and Sangha Community.
- (4) To support the people.

Item 9: The qualifications of the social services students are as follows :-

- (1) Students who are studying over the second year.
- (2) The cumulative grade point average (GPA) no less than 2.00.

Item 10: Students have to practice social services no less than 200 hours, except, the foreign students have no practice.

Item 11: Where place to practice, students have to request for services to the University as specified.

Item 12: Students have to join the orientation which University has specified.

Item 13: During the social services practice, if students have necessity to move to another place, it must be approved by University as specified.

Item 14: The report of the social services practice :

(1) Students have to report regularly the social services practice to their advisor as the University specified.

(2) After completing the practice within 200 hours, students have to report their social services practice as the University specified.

Item 15: University has appointed the lecturer to be an advisor to each student.

Item 16: University will not approve the Degree for 2 years for students, who violate the regulation as follows,

- (1) No practice the social services
- (2) Leave during the social services practice
- (3) Not report or report the fake to University.

Item 17: Students are practicing the social services, if they do not act in appropriate ways which constitute the disgrace to the university. When committee has investigated what is wrong, they are punished by,

- (1) Reprimand
- (2) Probation
- (3) Restrain the degree for 2 years
- (4) Termination
